Fees and charges (if applicable)

BEFORE YOU MOVE IN:

Set up fee (tenant's share)

£240.00 (inc VAT)

Referencing (identity, immigration and visa confirmation, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability) as well as contract negotiation (amending and agreeing terms) and arranging the tenancy and agreement

Additional Tenant Fee

£120.00 (inc VAT) per tenant

Processing the application, associated paperwork and referencing

Guarantor Fee

£90.00 (inc VAT) per guarantor (if required)

Covering credit referencing and preparing a Deed of Guarantee as part of the Tenancy Agreement

Company Tenant fee

£360.00 (inc VAT)

Processing the application, associated paperwork and referencing. Contract negotiation (amending and agreeing terms) and arranging the tenancy and agreement

Room only fee

£120.00 (inc VAT)

Processing the application, associated paperwork and referencing. Contract negotiation (amending and agreeing terms) and arranging the tenancy and agreement

Accompanied Check-in Fee

£60.00 (inc VAT) if applicable

Handover at Property taking meter readings for utilities and services and releasing the keys

Out of hours sign in fee

£48.00 (inc VAT)

paperwork signing and release of keys from 6pm Monday to Friday and after 1pm Saturdays

Pet Deposit

Returnable additional Security Deposit of £100.00

To cover the added risk of property damage. This will be protected with your security deposit in a Government-authorised scheme and may be returned at the end of the tenancy

Tenancy Amendment Fee

£60.00 (inc VAT)

Contract negotiation, amending terms and updating your tenancy agreement during your tenancy

Change of sharer/additional tenant fee

£150.00 (inc VAT)

Referencing (identity, immigration and visa confirmation, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability) as well as contract negotiation (amending and agreeing terms) and arranging the tenancy and agreement

Renewal Fee (tenant's share)

£36.00 (inc VAT)

Future Landlord Reference Fee

Early release fee

Lost Security Items

£24.00 (inc VAT) plus item cost

Obtaining necessary permissions, sourcing providers and travel costs

Out of Hours Services

£24.00 per hour (inc VAT) plus any actual costs incurred

Where actions of the tenant results in the agent (or nominated contractor) attending the property, time to remedy the situation is charged at the hourly rate

Unpaid Rent / Returned Payments
